Promotional Period	Start Date 12:00pm 22/08/2025 End Date: 5:00pm 25/08/2025
Eligible Entrants	1. Entry is open to Australian residents over 18 years of age. 2. Employees of the Promoter and their immediate families are not eligible to enter.
How to Enter	1. To enter the Promotion, the entrant must complete the Anita's Theatre 2025 Patron Survey during the Promotional Period. 2. By entering the Promotion, entrants accept these Rules. 3. Any entries submitted outside of the Promotional Period will not be accepted.
Entries Permitted	Entry into the Promotion is limited to one (1) entry per entrant. If it is discovered that an entrant has attempted to exceed this entry limit, all entries submitted by that entrant will be void.
Prize	One (1) double pass (admit two (2)) to a selected performance at Anita's Theatre. Passes to performances are subject to availability. Attendance must be taken to coincide with the selected performance. Prizes are only valid on the dates advised by the Promoter and can only be redeemed in accordance with the Prize supplier's terms and conditions.
Prize Value	Approximately of a value up to AUD \$80 - \$150. Final Prize value is dependent on the selected performance.
Prize Conditions	1. The winner consents to the Promoter, without royalty or any fees, using their name, likeness, image, voice and entry in any marketing and promotion of the Promotion, the Promoter or the Promoter's business. 2. The winner agrees to comply with all the conditions of use of the Prize (including but not limited to venue conditions of entry, and ticket terms and conditions) and the Prize supplier's requirements. It is the responsibility of the winner to confirm such conditions with the Prize supplier or other relevant third parties.

Winner Notification	The winner will be notified via email within seven (7) days of the draw. Proof of identification must be provided upon request.

Unclaimed Prizes	1. The winner must accept the Prize within 14 days after being drawn as the winner ("Unclaimed Prize Date"). 	2. Any further draw winner will be notified via email within seven (7) days of the further draw. 3. If efforts to confirm a winner in accordance with these Rules are unsuccessful, the Promoter reserves the right, in its sole discretion, to award no Prize in this Promotion.
General Terms	1. All decisions of the Promoter with respect to any aspect of the Promotion, including without limitation the eligibility of entries, are final and binding on all entrants in all matters as they relate to this Promotion. 2. The named individual winner must be the individual that proceeds with the Prize. 3. Entries must not contain derogatory characterisations of any ethnic, racial, sexual or religious groups, references to illegal or inappropriate activity, behaviour or conduct, or any other references that could be considered inappropriate, unsuitable or offensive, as determined by the Promoter, in its sole discretion.
